JAIL INFORMATION SHEET FOR INCOMING COMMITMENTS

The booking process includes an inventory of every item that an inmate brings into the jail. In an effort to reduce the booking time for each inmate. ***WE REQUEST THAT YOU ONLY BRING ITEMS THAT ARE ALLOWED AND NECESSARY.***

WHAT YOU MUST HAVE

Current picture identification
\$30.00 for the "Basic Mat Rental" and the "Inmate Processing Fee"

WHAT IS PERMITTED IN THE JAIL

All whites, which include socks, underwear, bras, and t-shirts must be purchased through the jail commissary. Due to contraband issues they can not be brought into the facility.

Cash or money orders may be brought in for purchasing items on commissary such as soap, shampoo, deodorant, stationary, toothbrush, toothpaste and certain extra food items.
Please bring U.S. currency. (No foreign monies or checks will be accepted)

You will need a Minimum of \$30.00 for the "Basic Mat Rental" and the "Inmate Processing Fee"-See additional Prices attached

School books –**ONLY WITH ADVANCED APPROVAL FROM JAIL STAFF**

PRESCRIPTION MEDICATIONS

THE KNOX COUNTY JAIL NO LONGER ACCEPTS PRESCRIPTION DRUGS OF ANY KIND. MEDICAL STAFF SHALL EVALUATE ANY POTENTIAL LIFE SAVING MEDICATION.

WHAT IS NOT ALLOWED IN THE JAIL

Tobacco products of any kind. Food items of any kind that are not purchased through commissary. Matches, lighters or other sparking devices.

Any item not found on “allowed list”

COMMISSARY

If you place an order and you are not here when it is delivered you will have five (5) days to come to the jail and claim it. After 5 days it will become the property of the Knox County Sheriff's Office.

Please Note:

When ordering commissary you must have your order in before 8:30am on **Tuesday**. There is no “pre-ordering”, so if you are a weekend commitment you will not be able to purchase items on commissary.
